GENERAL BID SPECIFICATIONS

All contractors shall provide a list of at least three references of work of similar nature to that being bid for, so that Canaan Township can judge experience, skill, and business standing.

All contractors shall have a State of Ohio Certificate of Qualifications from the Department of Transportation accompanying each bid.

Bidder will be required to verify that all employees used in the work will be paid the minimum wage rates established for each classification by the Ohio Department of Labor and comply with Chap. 4115 of the Ohio Revised Code as it applies to prevailing wage rate.

A bid bond, certified check or official bank check in the amount of 10% of bid shall accompany each proposal as a guarantee to contract, which shall be returned promptly to the unsuccessful bidders upon acceptance of a bid by Canaan Township.

Canaan Township reserves the right to reject any and/or all bids and to waive any informality in bids.

Award will be made to the lowest and/or best responsible bidder.

In Case of default by the bidder or contractor, Canaan Township may procure the article from other sources and hold the bidder or contractor responsible for any excess cost occasioned thereby, or may cause any performance bond posted to be forfeited.

The bidder shall list on a separate sheet of paper, any variations from, or exceptions to, the conditions and specifications of this bid. This sheet shall be labeled "Exceptions to Bid Conditions and Specifications" and shall be attached to the bid.

Bituminous distributor and aggregate spreaders shall have computerized rate controls that automatically adjusts the spread rate to the ground speed.

All materials shall comply with all applicable sections of the current issue of State of Ohio Department of Transportation Construction & Material Specifications.

Delivery shall be made when ordered by Canaan Township.

Heatable storage of 10,000 gallons must be maintained in close proximity of Canaan Township during road work to insure proper temperature and speed of the work.

INSURANCE PROVISION

It is agreed that the bidder will save and hold harmless Canaan Township, its employees, agents, and officials against any liability in connection with the work or service performed by the bidder for Canaan Township.

The bidder agrees to furnish Canaan Township with a certificate of insurance showing proof that the bidder has liability insurance in the amount of \$2,000,000 bodily injury liability and \$500,000 property damage liability, and that the bidder also has contractual liability coverage.

PROPOSAL

To furnish and deliver all materials as specified and to do and perform all work necessary to furnish said material as ordered.

The undersigned bidder understands that the quantities of material as shown herein are approximate only and are subject to increase or decrease, and agrees to furnish the material whether the quantities are increased or decreased at the unit prices stated in the bid.
